

OPEN AUCTION NOTICE

An open auction for disposal of unserviceable items like Wooden/Door Window, T. Steel and Sq./Rubble Stones, will be held at District Hospital Ramban on 28-10-2015 at 3.30 PM to 5.00 PM. The terms & conditions of the auction are as under:-

1. Each bidder will have to deposit an amount of Rs. 5000/- (Rupees Five thousand) only as security money deposit in cash at the time of the auction to become eligible for bidding. The security amount is refundable to all the bidders except the highest bidder at the end of auction.
2. The highest bidder shall have to deposit 50% of total cost at the end of the auction. The security money deposit can be adjusted in 50% deposit. The highest bidder has to make full payment of the total declared cost before lifting the auctioned items. The payment to be deposited in the office of Medical Superintendent D.H. Ramban.
3. No complaint about the quantity, quality or condition of the material will be entertained after the auction. The items would be handed over to the highest bidder on 28-10-2015. The office shall not be responsible for their usefulness or quality.
4. In case of any dispute the decision of the Chief Medical Officer will be final and binding.
5. The highest bidder shall have to make his own arrangements for transportation, loading/unloading and permit (if required) etc. after acceptance of his bid. The bidder shall have to pay all the local taxes, sale tax, Surcharge or any other tax with the concerned authorities, if applicable, in addition to the amount offered.
6. The Security money deposited by the highest bidder will be adjusted in the total offered price.
7. The highest bidder has to lift the auctioned items within three days from the date of bidding after acceptance of the highest bid.
8. In case the highest bidder is unable to lift the material within specified period after acceptance of his highest bid, the total amount deposited along with the security money deposited shall be forfeited.
9. The lowest reserved bid amount has been fixed by Committee is Rs.2.54 lacs and the intending parties are required to go for bidding over and above the amount.
10. The Chief Medical Officer reserves the rights to accept or reject or add/alter any further terms and conditions at his discretion at any time in public interest.

The Office reserves the rights to reject accept any bid without assigning any reason whatsoever with the approval of the Committee constituted for the purpose.


